## Circular

Issued under Chapter VII, Section 52, Civil Aviation Act of Bhutan 2016

Title: Revised Fees and Charges on Personnel Licensing

Pursuant to Chapter VII, Section 52 of Civil Aviation Act of Bhutan 2016 the head of the Bhutan Civil Aviation Authority (BCAA), who is the Director General, shall have the power to issue, Circulars, Directives, Circulars and Notices regarding any matter as per the provisions of rules and regulations under this Act as and when deemed necessary in the interest of safety and security of civil aviation.

Accordingly, the undersigned do hereby issue the Circular on the revised fees and charges on personnel licensing for the purpose of giving effect to the provisions in the aforementioned act, regulations and the applicable standards and procedures described under Article 37 of the ICAO convention, which are herein specified.

This Circular which is applicable to the issuance, validation, renewal, extension, revalidation, or amendment of any licence, certificate, permit, approval or any other form of legal authority or document to be granted or any other service to be rendered either by the Bhutan Civil Aviation Authority or Director General shall come into force with immediate effect and remain in force unless revoked or superseded.

The fees to be levied for the issue, validation, renewal, extension or amendment of any licence, certificate, permit, approval or any other form of legal authority or document to be granted or any other service to be rendered either by Bhutan Civil Aviation Authority or Director General shall be as specified in the Schedule hereto.

Attention is also drawn to Chapter X, Section 147 of the Civil Aviation Act of Bhutan 2016, which states that a person who contravenes any provisions of this Act or rules and regulations not covered in this chapter, commits an offence and upon conviction, shall be liable to penalty prescribed in the rules and regulations and enforcement manual developed and issued under this Act or the Penal Code of Bhutan.
