Note:

(1)To qualify for renewal of a licence : The applicant is required to produce logbook evidence of at least six hours flying as pilot including six take offs and six landings on each class of aircraft(eg. Landplanes, and helicopters) for which the licence is rated, during the six months prior o the date of application for renewal.

If the licence contains a group 1 rating this flying time must be as pilot in command under supervision. When the licence contains only a group 2 rating, co-pilot time and landings and take-offs made under supervision may be counted.

(2) To qualify for the retention of a type in group 1 (PIC) of the aircraft rating : The qualification is one flight as pilot in command or pilot in command under supervision on each type during the preceding last twelve months. With exception of certain aircraft regarded by the authority as “simple” types/type which the applicant is not qualified to retain in group 1, are downgraded to group 2 or, if not dual-controlled are removed from the licence. Types so downgraded or removed will be restored to group 1 if the applicant passes the flying test.

(3) When flying as pilot-in-command under supervision is claimed the log book evidence must be certified by the captain of the aircraft
