- 3. Airline and seats must be confirmed while submitting the quotation and submit confirmed itineraries.
- 4. The validation of fares and availability of seats should be as per the details mentioned above.
- 5. Unconditional quotations like an increase of fares during the booking or during the issue of tickets or changes of airlines at the time of travel are not entertained.

- 7. Tender document should contain EMD of Nu. 10,000/- in the form of Demand Draft or Bank Guaranteed, a photocopy of valid trade license issued by Ministry of Economic Affairs and tax clearance certificate issued by RRCO.
- 8. In case the lowest bidder withdraws his/her bid then the second lowest bidder shall be asked to purchase and issue ticket(s) and the difference amount shall be borne by the lowest bidder.
- 9. Quotation without EMD, valid documents and without sealed envelope will be rejected.
