5. Unconditional quotations like an increase of fares during the booking or during the issue of tickets or changes of airlines at the time of travel are not entertained.
6. The successful bidder should submit the photocopy of every air ticket along with their invoices for payment.
7. **Tender document should contain EMD of Nu. 10,000/- in the form of Demand Draft or Bank Guaranteed, a photocopy of valid trade license issued by Ministry of Economic Affairs and tax clearance certificate issued by RRCO.**
